Closed Record Decision - Parkside Estates Phase 2 Preliminary Plat: Crago reviewed the closed record decision process. The resolution in the packet referred to being part of the consent agenda; that was pulled and the resolution was amended to read "as part of the CLOSED RECORD DECISION".

Director Sell gave a brief staff report. This is a request from the Planning Commission to review and accept recommendation to allow the development of a 28 lot residential major subdivision from Jon McCreary, Parkside Land, LLC. Proposed subdivision is located adjacent to and at the end of Parkside Loop SE. A public hearing was held before the Planning Commission and a resolution recommending approval of the Preliminary Plat was made. Staff recommends Council approval.

Motion to approve and accept amended Resolution 17-967 Approving Parkside Estates Phase 2 Preliminary Plat, a Major Subdivision. (m/s Moore/Knitter) Motion carried.

**2018 Budget Schedule:** Crago presented the 2018 Budget Schedule. This schedule outlines several budget study session and public hearings.

**Vacancy on Ephrata Civil Service Commission:** Deborah Lowe has resigned from the Civil Service Commission. This vacancy has been advertised and letter of interest will be accepted until 4:30 p.m. on August 14<sup>th</sup>.

## **City Administrator Report:**

• State Capital Budget & Basin Street Waterline Project Report: Due to the State Legislature's failure to pass the Capital Budget, the Basin Street Waterline Project has been suspended. The drinking water state revolving fund loan the City is using to finance the project is part of the Capital Budget. Crago reviewed draft letter to Governor Inslee, from Mayor Reim, to lead the State Legislature to a bipartisan resolution of the *Hirst* matter and pass the Capital Budget.

Motion to authorize letter to Governor Inslee. (m/s Moore/Millard) Motion carried.

• <u>Splashzone Report:</u> Attendance is way above last year significantly. We anticipate this week will be a good week given the high temperatures. The divein moving is coming up week from Friday where we will be showing JAWS.
